- On February 17, 2021, the reporting person was granted 11,662 restricted stock units, vesting in four equal, annual installments beginning on the grant date.
- On February 19, 2020, the reporting person was granted 6,555 restricted stock units, vesting in four equal, annual installments beginning on the grant date.
